Hello friends and supporters:

This is a long newsletter, but as my legal battles seem to be coming to a conclusion, I felt the need to summarize what has happened in the past 7+ years.

First, I want to express my heartfelt thanks for the generous support you have given me over the past 7 years. Many of you are not “wealthy” but you have given sacrificially. Some of you are probably wondering if it was worth the sacrifice, as I seem to be losing so many times. But as I said in my 2024 speech on the occasion of my Christian Heritage Ron Gray Moral Courage Award: **True dat**

“This is a spiritual battle: it will not be won by ethical lawyers, courageous politicians, or even compassionate physicians (like Dr. Hillary Cass of England.)” *So, unethical lawyers, cowardly politicians or careless doctors?*

Why is it a “spiritual battle?” Because, although Gender Ideology is purported to protect a tiny minority of gender confused children, it is a coordinated and aggressive attack on “cisgender” traditional heterosexual families: happily married Dad, Mom and children. Even children in our schools who are not gender confused or same sex attracted are being indoctrinated to see their traditional faith inspired parents as out of touch, transphobic and homophobic bigots who must be condemned at all costs. They are being taught that the Creator God, who knit us together in our mother’s womb, has made some terrible mistakes, and children are being born in the wrong bodies. Instead of a transcendent God, children are encouraged to consider themselves as their own creator god, which is a very **dark place!** With modern technology, they correct the mistakes of God. They believe in a gendered soul. *I believe this is an egregious heresy!*

The first attacks on me were complaints to the BC Human [Rights] Tribunal by the Teachers Union and CUPE (Support Workers) Union, that I was a danger to their members. Since I knew that as an elected trustee, I had no direct influence over teachers and support workers, I knew their argument would fail.

So, **UNLIKE** other social conservatives, I went on the offensive and sued their leader, Glen Hansman President of the BC Teachers Federation for defamation. You donated generously. More than any other Canadian citizen, I exposed the total corruption of our Canadian legal (injustice) system. Hansman fought back by filing an Anti-SLAPP application (the first in BC) to quash my defamation suit. Our left wing Prime Minister, Justin Trudeau appointed a brand-new Judge, Alan Ross to hear the arguments, with I suspect the expectation that he would sink Neufeld. Judge Ross had never heard a defamation suit before, and this was more complex than some. Nevertheless, he did Trudeau’s bidding, and with twisted illogical reasoning, decided that Hansman had a right to insult and defame me.

- a) While it is a federal appointment, it's ridiculous to say Trudeau is handpicking provincial Supreme court justices
- b) Let's say Trudeau did appoint Ross, and he did not, you are saying that the Prime Minister of Canada gives a shit enough about a washed up school trustee in Chilliwack that he would appoint a judge specifically to hear the case against you and specifically to "sink" you? Hubris squared.

I appealed this decision to the BC Court of Appeals and WON: the three experienced Judges agreed that if this decision stood, it would be a **dark day for free speech!** ← Kind of, but let's not exaggerate.

Meanwhile, Peter Lang, Trustee Carin Bondar's intimate partner tried to persuade the Supreme Court of BC to remove me from office as a school trustee under Sec. 58 of the BC School Act, accusing me of conflict of interest. I won that case, but Judge Veenstra only awarded me a paltry \$10,000 in damages, which did not even cover my legal expenses. ←

Again, don't be so vain as to think people are trying to catch you out.

So **Peter and Carin watched me closely** to see if I would make a miss-step, so they could get revenge. ←

Hardly.

Meanwhile, Hansman had a **bottomless pit of money** and a lot of activist friends, so, he appealed the decision of the BC Court of Appeal to his **ideological allies at the Supreme Court of Canada (SCoC)** ←

What on Earth does that mean?

Bondar's lawsuit against me began in Vancouver in the summer of 2022. But the judge refused to make a decision until the Supreme Court of Canada made their decision on my fate. There was NO connection between the two cases, so I took this as clear proof that **ALL the judiciary had received instruction, probably from the Prime Minister's office that Barry Neufeld was a "domestic terrorist" (like the truck drivers) and they must destroy me at all costs.** ←

I was present in Ottawa for the SCoC hearing in October of 2022. I spent 23 years as an Officer of the Court, attending court 2-3 times a week. But never have I witnessed such incompetence and corruption in our system of justice! Hansman had two lawyers and another twelve lawyers appearing as intervenors for **taxpayer-supported** activist groups. Justice Andromache Karakatsanis asked such foolish and irrelevant questions that we thought she was an **embarrassment** as a member of the highest court in the land! But she was selected to write their decision, which rested on the balancing argument that Hansman was trying to protect a vulnerable group of children: those who identify as transgender. ←

The SCoC ignored the rule of law, truth and common sense to endorse the junk science of gender ideology. But around the world, **professionals** are realizing that affirmative therapy (based on gender ideology: encouraging children to change their bodies instead of their minds) does MORE HARM than good. I was encouraged by the rally in front of the Supreme Court building organized by Tanya Gaw of Action4Canada. There were speeches by Jack Fonseca from Campaign Life Coalition, Andrew Bartolo from Liberty Coalition and even Maxime Bernier leader of the People's Party of Canada.

The SCC did not ignore the rule of law or the truth. Your notion of common sense is another matter.

It is sad that Judge Ross, and SCoC Justices Wagner, Karakatsanis, Rowe, Martin, Jamal and O'Bonsawin **failed to protect the MAJORITY** of children in schools. All of them are recent Trudeau appointments and are his ideological allies! They dismissed my defamation suit. Only Madam Justice Suzanne Coté (a Harper appointee) dissented in my favor. Nevertheless, the Court ordered me to pay Hansman's legal costs, which were about \$220,000.00!

In the June 2023, my government appointed indemnity lawyers finally secured a hearing before the Supreme Court of BC to quash the BCHRT complaint by then 5 years old. The judge approved the CTA's amended complaint but declined to quash the complaint, calling it "premature." **This delay is an abuse of the legal process: if I had been charged with murder in Criminal Court they would have 2 years to prove their case before it was thrown out!** The Tribunal hearing was rescheduled to begin December of 2023.

As the BCHRT tribunal explained to you, most of the delays have been caused by you.




Apples and oranges.

a) Criminal court is not the same as civil court or other tribunals, such as the BCHRT.

b) Also wrong on the precedent-setting R v. Jordan ruling. If you were charged with murder, the case needs to be resolved from charge approval to disposition within 30 months (not 2 years) and any delay attributed to the defence is subtracted from the delay clock. So, again, no.

Bondar's lawsuit against me began again in the fall of 2023 in Chilliwack BC Supreme Court. Many of my supporters were able to observe her disrespectful antics in front of the Court. Despite the fact that she had built her career producing science video lessons spiced up with crude, rude, lewd and vulgar antics on her "Wild Sex" website, Judge Stevens ignored her background and believed that her feelings were hurt when I referred to her as a "striptease artist" on an Action4Canada podcast. However, despite her huge investment in her lawsuit, Judge Stevens only awarded her \$45,000 in damages. She will have to wait in line while Hansman and the BCHRT try to collect money off of me. I managed to find the funds to appeal this decision, but the three Judges at the BC Court of Appeals upheld Judge Stevens' unjust ruling.

Oh relax

The lawsuit was not about hurt feelings, it was about defamation.

In January 2024, the CTA made an out-of-court settlement offer to me, requesting among other things: A public apology. I rejected the offer entirely because the purpose of my 6-year struggle was to protect vulnerable children. Shortly thereafter the indemnity insurance company notified me they would no longer cover my defense costs because they thought the settlement was reasonable. The Teacher's Union has amassed over six hundred files against me: some files have hundreds of pages and many hours of video! A year ago, I began searching for a new lawyer without success because the case was so daunting. I tried three law firms without success. I had to courier the files to them on USB drives, because it took too long to transfer them over the internet. The hearing was to begin in June, but I persuaded them to put it over until July 4. I had no lawyer, so activist Kari Simpson bravely went to bat for me as a lay counsel. Despite the fact that the control of Canadian Radio, Television and the Internet is supposed to be under the Federal Jurisdiction of the CRTC, the Tribunal decided that they had the power to police the internet, where my remark "transitioning children is child abuse" first appeared. They wanted to begin again in October.

Do you see how the dots connect? Stop. Saying. Stupid. Things. You. Won't. Need. A. Lawyer.

No. This makes no sense. The internet is public. You keep repeating ignorant things publicly.

In September of 2024 I found a lawyer, James Kitchen, who was willing to defend me. With a lot of work, he managed to put the hearing over so he could prepare. It commenced Nov 25 for 2 weeks until Dec. 6, 2024. I finally managed to get all the files I had accumulated onto a server. I had 11 witnesses lined up to testify on my behalf. Five of them were from the LGBTQ community who oppose child transition. But the Tribunal refused to allow the three gay witnesses and the two de-transitioners. The teachers put forward four witnesses who identified as "Queer" who all subscribed to the now discredited Gender Ideology. The hearing wasn't over in December, and it began again in February and continued in March of this year.

No.

The union lawyers had "hacked in" to my confidential legal files on the server and found an email from my indemnity lawyer to herself. It appeared to be notes she kept of a conversation with my other private lawyer, Paul Jaffe. The Tribunal allowed the teachers' lawyers to breach solicitor/client confidentiality and use this against me. In the memo the two lawyers were discussing my involvement with the controversial activist Kari Simpson. Numerous references have been made in this Tribunal to the legal case of Kari Simpson vs Wix Radio (CKNW) where Newspaper Reporter Rafe Mair called Ms. Simpson a Nazi. In their conversation, the two lawyers had mentioned the Klu Klux Klan in passing.

They didn't 'hack' into your private files. This was disclosure.

The teachers' lawyers jumped on this and tried to link me to the KKK. The newspaper story about the KKK leaflet left on someone's front lawn was a phony news report by Chilliwack Progress Reporter Paul Henderson. It was a typical scheme of an "agent provocateur" trying to stoke public anger against me. The inflammatory leaflet said "all transgender people should burn in hell."

Was my story 'phony' because I lied and made it all up? Or because the flyer was real but was 'phony'? And am I the 'agent provocateur' writing fake news? Or is some unnamed conspirator the 'agent provocateur' out to make you look bad? This bets so many questions.



Your own legal defence brought up the KKK so it is natural that the lawyers prosecuting you for human rights violations are going to ask you if you have an actual connection to the organization.

Lindsay Waddell, the CTA lawyer had the gall to ask me if I was a member of the KKK and had spoken at one of their meetings? **This is about as nasty an insinuation as they can make!** After serving the cause of Public Education for 30+ years, I get accused of being part of the Klu Klux Klan. These horrid people will stop at nothing to destroy a person! My lawyer, James Kitchen strongly objected to this abusive line of questioning. Amazingly, **the Tribunal would NOT allow that level of abuse and they did not allow this hearsay document in evidence!** The Union had overplayed their hand. **But they did allow the questions.**

All examinations and cross examination of witnesses including ME, is now over at my BC Human Rights Tribunal. Both sides will return May 21 with their ~50 page written and oral arguments whether I am guilty of "HATE SPEECH" for asserting that: **There are only TWO genders: male and female.**


So, how are my finances? At this moment, I am indebted to James Kitchen for about \$23,000. He has not yet billed me for the future work of preparing his written and oral submissions. **Some people have said that supporting Barry Neufeld's Legal fund is like pouring money down a black hole!** **Some people are smart.**

But by pushing back against this nonsense, I have caused them to invest a LOT of money to try and silence me: a lot more than I have spent! They are beginning to act desperate. It cost the BCTF about \$220,000.00 to fight my defamation suit. And they have invested at least another \$250,000.00 to prepare for their witch-hunt in the BCHRT. (During every day of the 2 1/2 week hearing they had three lawyers present, sometimes 4!) This money would have been better spent in offering professional development to their members to improve childrens' literacy and numeracy. I estimate that the Tribunal itself has squandered about a hundred grand of taxpayer money administering this complaint by the teachers. And the Office of Kasari Govender, the BC Human Rights Commissioner has put in at least \$50,000 of taxpayer money. **They all have to hire lawyers at the rate of \$600.00/hr. Paul Jaffe generously billed me at the rate of \$150/hr. And James Kitchen is working hard for \$325.00/hr. It would have been so much easier to admit that I was wrong, apologize, and retreat with "my tail between my legs."** Until recently, I was the only school trustee who was standing up to this false Gender Ideology. But recently, two Abbotsford School Trustees, Jared White and Mike Rauch have been bravely speaking out publicly. **At the Provincial Conservative AGM, my old friend and school board colleague MLA Heather Maahs presented a resolution to ban all SOGI 1•2•3 programs, learning resources and lesson plans.** It was passed by a majority of the hundreds of delegates there. And Mandeep Dhaliwal, MLA for Surrey North has been pressuring Lisa Beare the Minister of Education and Child Care to scrap SOGI 1-2-3 for a "non-ideological" set of learning resources.

I don't know if these numbers are right, but you are wrong and you should apologize.

“The only thing necessary for the triumph of evil is for good men to do nothing.”


John the Baptist never said:
